領取證明書方法 Collection Methods



親身申請 In person

You will be given a card notifying you of the date for collection of the result of search. You may either collect it in person or authorise a representative to do it on your behalf in writing. The authorization form can be obtained from any marriage registries.

網上申請 Through the internet

郵遞申請 By post

If you apply by post and the result shows that you have no marriage record in Hong Kong, you will be notified by post of paying the fee(s) required for obtaining a certificate of absence of marriage record. The certificate will be posted to you at the mailing address indicated in the application form on receipt of the required fee(s).

收集資料的目的 Purpose of Collection
